**DECISION**

This is an application by **Duffields Foodmarket Ltd** for a renewal of an off-licence in respect of premises situated at **60/72 High Street South, Carterton**, known as **New World Carterton**.

The application is in respect of premises in which the principal business is the supply and sale of alcohol. The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly, we deal with the matter on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.105 of the Act and we grant the applicant an off-licence.

The licence may issue immediately.

**This licence is subject to the following conditions:**

- a) no alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day
- b) alcohol may be sold only on the following days and during the following hours:  
Mondays to Sundays 7.00am to 10.00pm

The following steps must be taken to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed: **display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.**

- c) conditions prescribing steps to be taken by the licensee to ensure that the provisions of this Act relating to the management of the premises concerned are observed: **The Host Responsibility Policy must be displayed in view of the public.**
- d) Drinking water is to be freely available to customers, while alcohol is being supplied free as a sample.

e) A manager's register (as required by s.232 of the Act) is to be maintained and available on site.

The applicant's attention is drawn to ss.55, 56, 57 and 214 (3) of the Act obliging the holder of an off-licence to display: -

1. A sign attached to the exterior of the premises, to be readily read by persons outside each principal entrance, stating the ordinary hours of business during which the premises will be open for the sale of liquor; AND
2. A copy of the licence, and of the conditions of the licence, attached to the interior of the premises to be easily read by persons entering through each principal entrance; AND
3. A sign prominently displayed inside the premises, which identifies by name the manager for the time being on duty.
