



**Notification under section 95(A) of the Resource Management Act 1991
of Notice of Requirement: RM170011 for designation of land and the alteration
of an existing designation in the Wairarapa Combined District Plan and
application for resource consent: WAR160341 to facilitate the upgrading,
operation and maintenance of Carterton District Council Wastewater Treatment
and Wastewater Management Facilities**

Requiring Authority/Applicant: Carterton District Council

Location: Carterton Wastewater Treatment and Wastewater Management Facilities and associated land at Daleton Farm, Dalefield Road, Carterton

Notice of Requirement under Sections 168A & 181(4) Resource Management Act 1991)

Proposal: Carterton District Council (CDC) gives notice of:

- (a) A requirement for a designation for the operation, upgrading and maintenance of the wastewater treatment, storage and disposal activities for the purposes of wastewater management facilities and public amenity, being the operation of the Carterton municipal wastewater treatment plant and for the storage and irrigation to land of treated wastewater and in respect of the land, water, subsoil, or airspace necessary for the safe and efficient functioning or operation of that public work; and
- (b) Two alterations to the boundary of existing District Plan designation Dc006 ('Landfill'):
 - i. An alteration to the boundary between Dc006 ('Landfill') and existing designation Dc007 ('Sewage Treatment Plant'); and
 - ii. An alteration to the designation applied to a triangular corner of Dc006 from 'Landfill' to 'Wastewater Management Facilities and Public Amenity'; and
 - iii. No other changes are proposed to the purpose or scope of activities conducted within the designation Dc006 ('Landfill').
- (c) The land to which the notice of requirement applies and the designated purposes are specified in the notice of requirement and will amend Appendix 6 of the Wairarapa Combined District Plan.

Applications for Resource Consent (S.88 Resource Management Act 1991)

Proposal: *Greater Wellington Regional Council (GWRC) has received applications for the discharge of contaminants to land, water and air, the diversion of surface water, associated land use consents and the disturbance of land associated with the upgrading, operation and, maintenance of the Carterton District Council Wastewater Treatment and Wastewater Management Facilities:*

- 34718 *for the discharge of tertiary treated wastewater onto or into land in circumstances which may result in that treated wastewater, or any other contaminant emanating as a result of natural processes from that wastewater, entering ground water or surface water*
- 34719 *for the discharge to air of odour associated with the discharge of tertiary treated wastewater to air and land via centre pivot irrigators*
- 34720 *for the discharge to air of tertiary treated wastewater effluent via centre pivot irrigators*
- 34721 *for the discharge of tertiary treated wastewater into an unnamed tributary of the Mangatāre Stream*
- 34722 *for the discharge of contaminants including odour to air from facilities at the Carterton wastewater treatment plant*
- 34723 *for the discharge of partially treated wastewater effluent to land from the base of the secondary and tertiary oxidation ponds*
- 34724 *for the discharge of partially treated wastewater effluent to land from the base of existing wetland treatment areas*
- 34725 *for the incidental and accidental discharge of treated wastewater effluent to land from on-site pipelines supplying land irrigation areas and river discharge outfall and from the base of the proposed sequential batch reservoirs*
- 34726 *to disturb the bed, deposit soil and reclaim in, on, or under the bed of an ephemeral channel in the course of re-contouring a farm paddock*
- 34727 *to excavate and disturb land and to deposit material for the construction of storage reservoirs*
- 34728 *to divert water from an ephemeral channel and flood flows within the floodplain by altering the landform within a floodplain by the proposed re-contouring of land and construction of storage reservoirs*
- 34729 *for the discharge of tertiary treated wastewater into an unnamed tributary of the Mangatāre Stream, via the existing weir outfall*
- 34730 *for the establishment, use, occupation and maintenance of an outfall structure in or on the bed and bank of the Mangatāre Stream*
- 34731 *for the discharge of tertiary treated wastewater into the Mangatāre Stream*

To make a submission

Any person may make a submission on the Notice of Requirement and any or all of the applications to either Greater Wellington Regional Council or Carterton District Council. Please note that a copy of your submission must also be supplied to Carterton District Council as the requiring authority/ applicant (the address for service is detailed below). The notice of requirement and application will be considered jointly and Greater Wellington Regional Council will be responsible for providing administrative support for this joint process.

The submission must be in Form 13 (for the GWRC applications) or Form 21 (for the notice of requirement) and must include the following information:

1. Your name, postal address, telephone number, email address and facsimile number (if applicable).
2. Details of the application or notice of requirement in respect of which you are making the submission, including location.
3. Whether you support, oppose or are neutral to the application and/or notice of requirement.
4. Your submission, with reasons.
5. The decision you wish the authority to make.
6. Whether you wish to be heard in support of your submission.
