Conditions of Permit
Keeping Of More Than 2 Dogs On An Urban Property

1. If the property in which the dog owner/owners resides is leased or rented, the written consent of the property owner is required and must accompany the application before any consideration for a permit will be given.
2. The property must be fenced in a way that will keep the dogs confined within the property.
3. The area in which the dogs are to be housed must be kept in a hygienic manner so as not to create a nuisance from smell or flies.
4. Waste created by the dogs must be disposed of in an appropriate manner so as not to be unsightly or create offensive odour.
5. Each dog must receive sufficient exercise, food and fresh water for their good health.
6. The dogs must be restrained from causing a nuisance by barking.
7. All dogs must be currently registered and shall at all times be kept in accordance with the provisions of the Dog Control Act 1996, the Carterton District Council Control of Dogs Bylaw 2007 and the Animal Welfare Act 1999.
8. The property will be subject to an inspection by an Animal Control Officer who will submit a report to Council.
9. Neighbours most likely to be affected by the application will be canvassed and invited to make submissions.
10. The number of dogs kept on the property shall not exceed the number for which an approved permit has been given. Any alteration must meet the approval of Council issuing your permit prior to obtaining any additional dog.
11. The owner shall notify the Council should the dog numbers reduce to two or less rendering the permit null and void. Any deaths, sales or transfers of dogs kept, including pups born to dogs kept on the property, must be notified in writing to Council within 14 days.
12. Change of permit address will require a new permit application.
13. Proposals for dog breeding or boarding kennels are subject to a separate application for discretionary use under the District Plan. Such applications will be publicly notified. Details obtainable from Council.
14. Council retains the right to:
 - a. Refuse the granting of a permit for the keeping of two or more dogs or
 - b. Revoke a permit so issued if the conditions above are at any time breached and not rectified following written notice by Council and within the period of time as may be provided for in that notice.
 - c. Issue notice to remove one or more dogs permanently from the property should a permit be revoked.
