LOCAL GOVERNMENT OFFICIAL INFORMATION AND MEETINGS ACT Request: 2024-40

Thank you for your email of Monday 9 September 2024 to the Carterton District Council requesting the following information:

"...please complete for the five rows in the table below the Supply Component ID, and any notes, if any, you think are important we know about it.

- For current sample sites, the current Taumata Arowai Supply Component ID is sufficient (even if it has changed over time).
- For inactive sample sites (e.g. decommissioned bores), the ID relevant at the time is sufficient.
- If a row is for a Source or Plant and you are unable to identify the historic Supply Component ID, then could you please record the current Zone that the Source or Plant would have supplied.
- Add a note so we are aware it is not the sample site.

We have added the information provided in the original file related to a testing site as well as its date and name of the file that was provided to us."

Your request has been considered under the Local Government Official Information and Meeting Act 1987 (the Act).

The water samples were collected from private bores and have never been used for any supply other than single households. The samples were taken for the support of a wastewater to land discharge and transported with the Council samples. There is no MoH or Taumata Arowai codes, or supply identification.

As requested, the five rows in the table below the Supply Component ID, and any notes we have included in the table provided attached as **Appendix One.**
