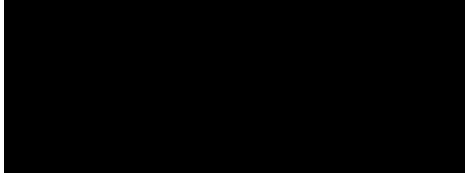
Hi good morning to you.
