

#### LOCAL GOVERNMENT OFFICIAL INFORMATION AND MEETINGS ACT Request: 2024-54

Thank you for your email of Tuesday 5 November 2024 to the Carterton District Council (CDC) requesting the following information:

"NZ Clean Energy Application RM 240005 With regards to the above application, can you confirm if any flyers / letters were distributed throughout the East Taratahi neighbourhood? If so are you able to provide a copy and confirm who they were sent to?"

Your request has been considered under the Local Government Official Information and Meeting Act 1987 (the Act).

In response to your request relating to NZ Clean Energy Application RM 240005, no flyers were delivered by CDC. We notified 19 adjacent properties and 8 entities, attached as **Appendix A** is a copy of the letter that was sent to the identified parties. The second letter is a copy of what was sent to the applicant listing who was notified and the addresses. Please note some information has been withheld under section 7(2)(a) of the Act, to protect the privacy of natural persons.

Where information has been withheld under section 7(2), I have considered, as required under section 7(1) of the Act, the public interest considerations favouring its release. I have identified no public interest considerations which outweigh the need to withhold information at this time.

Any person may make a submission on the application. However, if the person making a submission is a trade competitor of the applicant, then the submission may only be made if such person is directly affected by an effect of the activity to which the application relates, that –

- (a) adversely affects the environment; and
- (b) does not relate to trade competition or the effects of trade competition.

If you wish to make a submission of the application, you may do so by sending a written submission no later than 4pm on **4pm 30**th **July 2024** to either:

- Whether or not you are a Trade Competitor for the purposes of section 308B of the Resource Management Act 1991.
- The specific parts of the application that your submission relates to, and whether you support or oppose the resource consent application in whole or in part, or whether you are neutral.
- The reasons for your submission.
- The decision that you are seeking the Council to make.
- Whether you wish to be heard in support of your submission, and whether you wish to present a joint submission at any hearing of the application.
- Whether you request the Council to delegate its functions and powers to hear and decide the application to 1 or more hearings commissioners who are not members of the Council.
- Your signature and date of the submission.
- Your name and contact details, including electronic address (email) and/or specific contact person (if that is how you wish to be contactable).
