Strategic Context

This Speed Management Plan is in accordance with the Land Transport Rule: Setting of Speed Limits 2024 (the Rule). The plan is consistent with the road safety aspects of the GPS on land transport as it focuses on areas with high safety concerns. These areas are:

- peri-urban and urban areas with high cycling and pedestrian activity
- rural areas with high exposure to infrastructure risk e.g., narrow seal width, drop-offs
- unsealed roads

Council's approach to speed management includes regular review of road safety risk considering crash records, community requests, and infrastructure risk. Interventions are identified along with funding sources. As the Council area is composed mostly of remote rural areas the interventions are generally low cost with appropriate use of signs, lines targeted at specific locations so that the speed limits match safety risk.

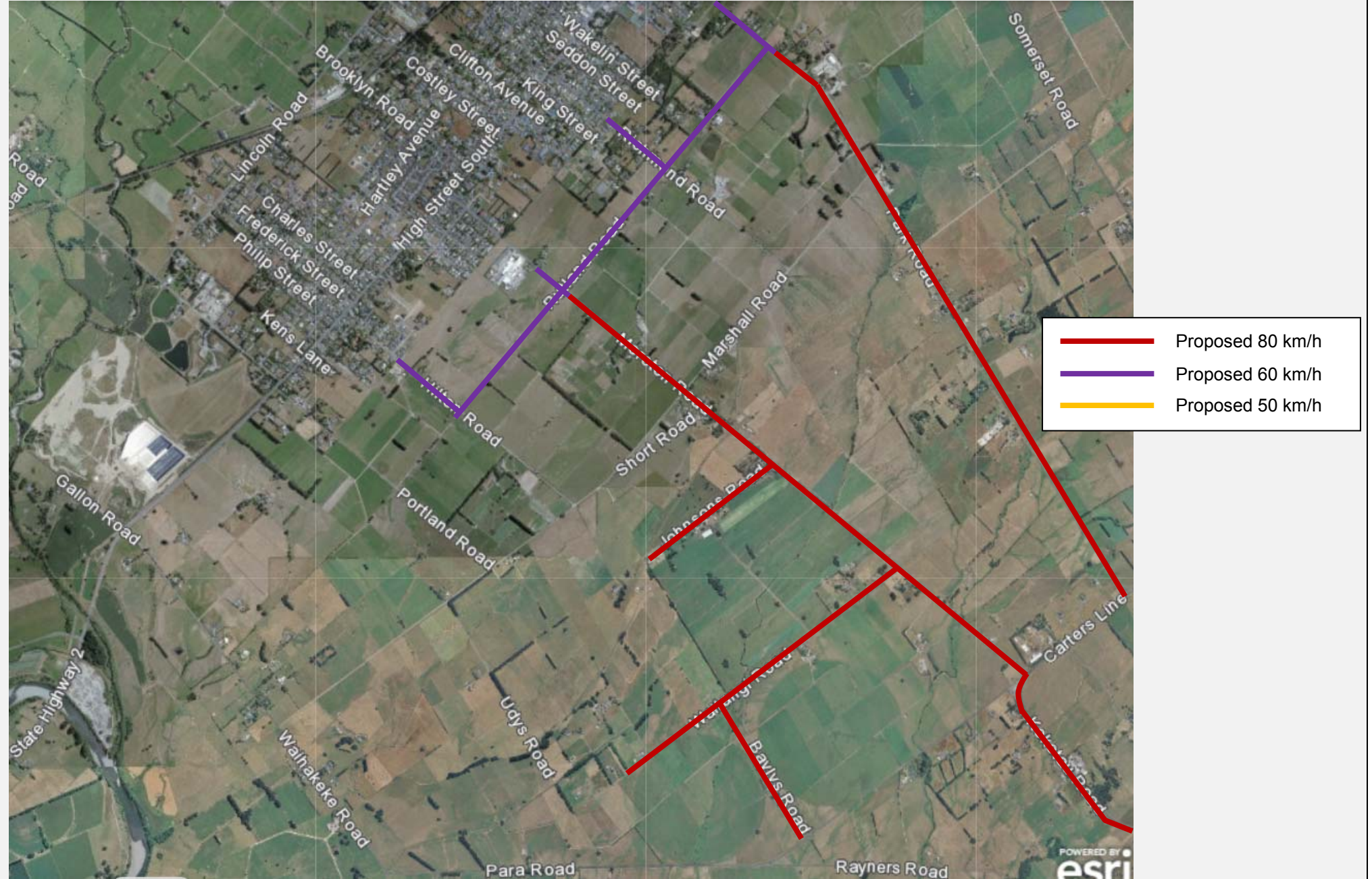


Figure 3 Proposed changes northeast of Carterton

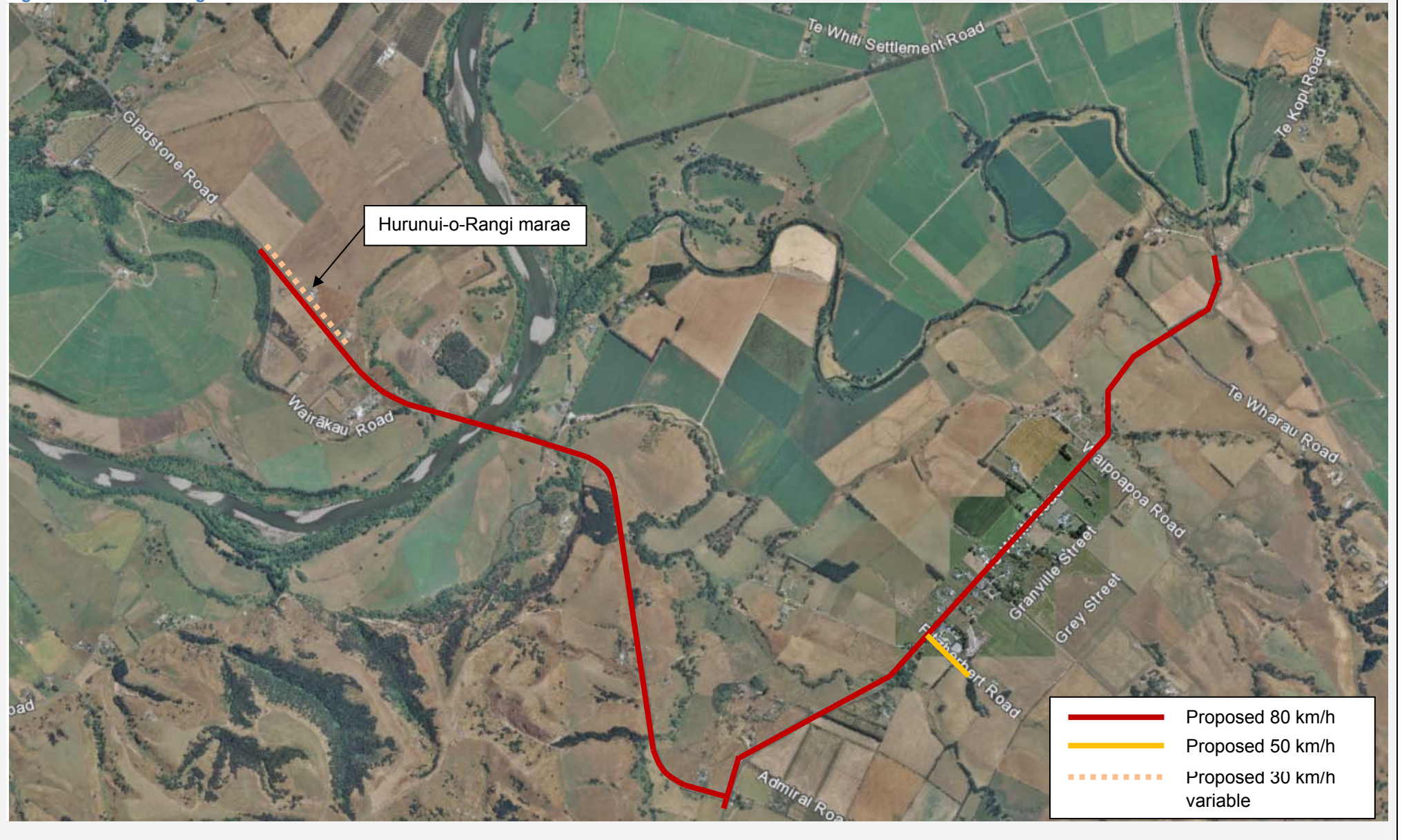


Figure 5 Proposed changes from Carterton south to Longbush

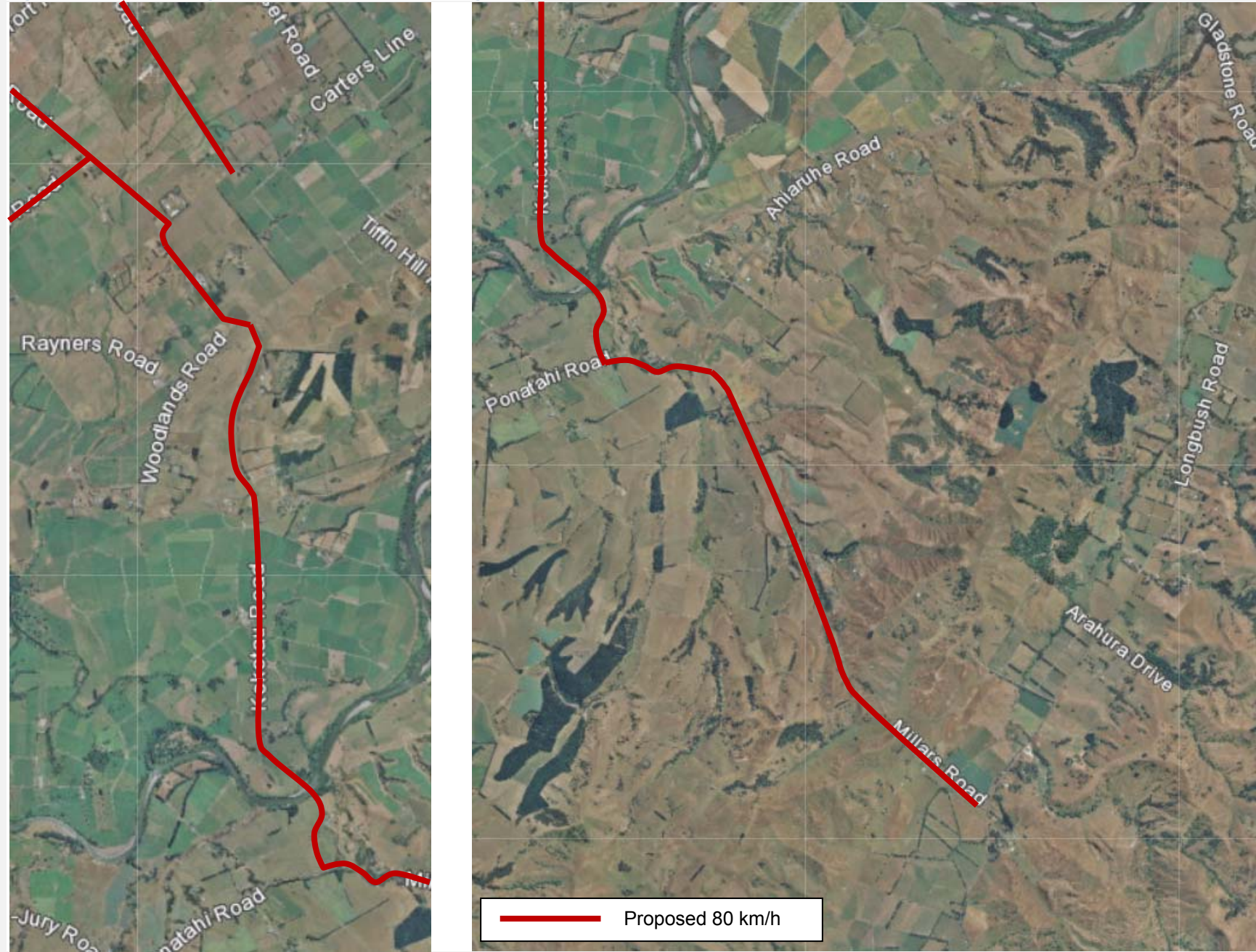


Figure 6 Proposed changes on Mount Holdsworth Road
