- Written agreement from other family members
- Extra details for special plot types [for example, natural burials]



What happens next?

- 1. We check whether your preferred plot is available.
- 2. We contact you if we need more information.
- 3. We send an invoice to the applicant.
- 4. When payment is received, we issue your Exclusive Right of Interment certificate.
- 5. We update our cemetery records.
- 6. When a burial or interment is needed in the future, your family or funeral director must provide the certificate so we can confirm the right.

How long do rights last?

The Exclusive Right of Interment lasts for the period stated in the Bylaw. If the right expires and we cannot contact you or your next of kin, the plot may be returned to general availability following the process in the bylaw.

Updating or Transferring

If you want to update your details or transfer the right to another person, please contact the Council at **cemeteries@cdc.govt.nz**. We may ask for proof of identity or family consent.
