## **LOCAL GOVERNMENT OFFICIAL INFORMATION AND MEETINGS ACT Request: 2025-66**

Thank you for your email of Tuesday 9 December 2025 to the Carterton District Council requesting the following information:

"Thank you so much for your prompt response to our request for information and for sending us the link to your district geospatial information.

This is a great start but we are really looking for more explicit detail.

Our land use map compiler comments: "It has the parks, but we'd also like to know the nature of the protection afforded --- i.e. is it under the Reserves Act 1977? If so, what type of reserve is each of the parks under that Act? Is it a local purpose reserve under Section 23? When did the park come into existence?"

Of course, in an ideal world, all authorities would keep their data in their API to include this information.

Also, **what are the license terms** for using that dataset? In many cases the license is simply unstated; we need it to be explicitly CC BY (and not CC BY-ND)."
