**LOCAL GOVERNMENT OFFICIAL INFORMATION AND MEETINGS ACT Request: 2025-67**

Thank you for your email of Wednesday 10 December 2025 to the Carterton District Council (CDC) requesting the following information:

*“...regarding provision for single-sex and gender neutral changing and showering facilities in any swimming pool or fitness centre sites that are owned and / or operated by your Council.*

1. *Do you provide communal single-sex changing and showering facilities?*
2. *Do you provide single occupancy changing and showering facilities? If so, how many at each site?*
3. *Please provide any policies or procedures that apply to trans-identified people who wish to use the changing and showering facilities in your sites.*
4. *How are your different changing and showering facilities labelled and described?*
5. *At your sites, which changing room and showering facilities is a trans-identified male permitted to use?*
6. *If applicable, do your facilities allow trans-identifying males to attend Women Only swim sessions.”*

Your request has been considered under the Local Government Official Information and Meetings Act 1987 (the Act). My response to your request is in the number order below.

1. *Do you provide communal single-sex changing and showering facilities?*

The outdoor pool that is operated by Council has cubical shower facilities.

2. *Do you provide single occupancy changing and showering facilities? If so, how many at each site?*

The swimming pool has cubical showers and toilets with communal changing space. The Wairarapa Events Centre has two singles occupancy showers.

3. *Please provide any policies or procedures that apply to trans-identified people who wish to use the changing and showering facilities in your sites.*

Not applicable.

4. *How are your different changing and showering facilities labelled and described?*

The pool signage is gender specific (male/female). At the Events Centre, it is a mixture of both gender specific signage for one set of toilet facilities and the other two facilities in the buildings are labelled toilets.

5. *At your sites, which changing room and showering facilities is a trans-identified male permitted to use?*

They can self-determine where they are most comfortable to change. Staff, if asked will provide advice and guidance if required.

6. *If applicable, do your facilities allow trans-identifying males to attend Women Only swim sessions."*
